CBT 2025 FAQs

1. When will the next CBT be conducted?

The next CBT, for session 2024-25 will be conducted in January 2025.

2. What is the timeline of events for CBT 2025?

3. Till when is P.E.C. issued for CBT 2024 valid?

P.E.C. 2024 for CBT 2024 issued in March 2024 is :

i) valid till March 2025 only, if the candidate has not been employed by any DAV school after CBT March 2024

ii) valid till March 2025 only, if the candidate joined a DAV school but wants to shift to some other DAV school.

iii) valid even after March 2025, if the candidate has got employment in a DAV school and till the year he/she will keep working in the same school.

4. When and where will CBT - January 2025 be advertised?

CBT January 2025 will be advertised in the second week of October 2024 all over India in various national and regional newspapers.

5. Who will be accountable for advertising in the newspaper?

It is advisable to advertise collectively at Regional/Zonal level for better visibility and outreach through the newspaper. ROs/AROs, cluster heads and all principals of the region/zone must confer and deliberate to decide this and allot CBT booths/feeder schools for collection of Application forms, as per distance, accessibility for the convenience of candidates.

6. In Phase 1, where/how will the candidates get the Application Form and where/how will they submit it?

It must be mentioned in the Advertisement where the candidates will get and submit the Application Form, e.g. either at CBT booth schools (hard copy on the counter) or downloadable PDF of the App. form be available on website/s. They will submit their duly filled forms with copies of certificates at the CBT Booth Schools (mentioned in the Advertisement).

7. What is the eligibility criteria to apply for different posts - teaching as well as ministerial posts in DAV?

Please follow DAVCMC and Central/State Govt. norms for eligibility.

8. How will the candidates fill the application form for CBT? Will it be available offline or Online?

The candidates will collect the Application Form either from CBT booth schools (hard copy on the counter - offline) or downloadable PDF of the App. form available on the region/school website/s (online). They will submit their duly filled forms with copies of certificates at the CBT Booth Schools (mentioned in the Advertisement).

9. For which posts will CBT 2025 be conducted? / Which posts should be advertised in the newspaper?

10. Who will have to appear for CBT 2025?

All those :

- who have never appeared in any DAV CBT [NEW APPLICANTS as per state wise eligibility criteria]
- Who did not qualify CBT 2024 [interested applicants eligible for applied post]
- Who qualified CBT 2024, but did not get any job in DAV till March 2025 and P.E.C. going to expire after 31 March 2025 [subject to eligibility]
- In-service teachers, who need promotion of designation only [eligibility for higher post required]
- CBT qualified candidate, who has got employment at a DAV school by virtue of CBT 2024, need not appear in CBT 2025, ONLY IF he/she continues to work in the same school at the

same post. However, for joining another DAV school, the candidate will have to appear in CBT 2025.

11. A teacher is working for 5 years on contract and has cleared CBT 2024. Does she/he have to appear for CBT in case there is a regular vacancy in school?

After 5 years of contract, DAV administrative manual does not allow recruitment of the same teacher on contract.

Case 1 - If the school does not regularise the teacher, legal issues may arise. If the school can/does not want to regularise, do not recruit this teacher again. He/she may apply for CBT 2025 and move to some other DAV school.

Case 2 - If school can/wants to regularise the teacher, no need to appear in CBT 2025, but Phase 3 will be followed.

12. I am a regular teacher working as PRT in a DAV School. Do I need to appear for CBT if there is a vacancy in the same school for TGT? What if there is a vacancy in some other DAV school nearby my location?

With due permission from your school Principal, you will appear in CBT 2025.

13. A Candidate cleared CBT 2024 and got a 3 year contractual appointment in a school till 2027. Does he/she have to appear in CBT 2025? If not, then Does he/she have to appear in the demo/ interview in phase II?

No need to appear in CBT 2025 if you are continuing in the same school. No need to appear in the demo/interview.

14. Currently, a candidate is staying in Delhi but he/she will move to Odisha in 4 months. From which state should the candidate apply for CBT 2025?

Apply from the state where you want the exam centre. After qualifying CBT, you can apply at any DAV school all over India.

15. If an applicant has cleared CBT for the post of PGT Mathematics, can he/she apply for TGT/PRT Mathematics in some other school?

To apply in some other DAV school, other than where the candidate is presently working, CBT 2025 is required for the desired post only.

16. I am based in Bihar. Can I appear for TGT Social Science and PRT English as I am eligible for both the posts?

Candidates can/must apply for 1 post only.

17. As per the new circular issued by CBSE the name of vacancy for Nursery teacher is Balvatika teacher. How will this vacancy be advertised?

Please mention Nursery/Bal-Vatika for more clarity.

18. Is there any fee for the CBT exam?

Yes, CBT fee will be charged from eligible candidates at the time of CBT Registration from November 21 to December 10, 2024.

19. How will the candidates get the roll number for CBT?

From the DAV Recruitment Website using their Registered Mobile No. (RMN).
